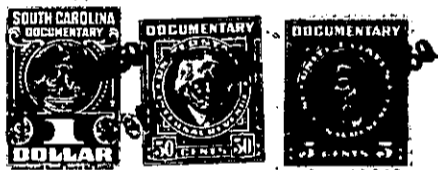

and other valuable considerations to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto H. P. Asay, Jr. and T. G. Crymes, Jr., their heirs and assigns, all that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, lying and being situate on the Southern side of Potomac Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lot #218, according to plat of Pleasant Valley prepared by Dalton & Neves, April, 1946, as revised through February, 1950, as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "P", page 88, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southern side of Potomac Avenue at joint front corner of Lots 218 and 219, said pin being 300 feet South west of an iron pin in the Southwest corner of the intersection of Potomac Avenue and Panama Avenue; thence S. 0-08 E. 160 feet to an iron pin at joint rear corner of Lots 218 and 219; thence S. 89-52 W. 60 feet to an iron pin at joint rear corner of Lots 217 and 218; thence N. 0-08 W. 160 feet to an iron pin at joint front corner of Lots 217 and 218 on the Southern side of Potomac Avenue; thence along said Potomac Avenue N. 89-52 E. 60 feet to an iron pin at joint front corner of Lots 218 and 219, the point of beginning.
