County, State of South Carolina on the Southern side of Lee Road, being known and designated as Lot #7 and Lot #8 as shown on plat of the property of James M. Edwards, made by Dalton and Neves, Engineers, in February 1941, and being more particularly described according to said plat, as follows:
Lot # 7: BEGINNING at an iron pin on the southern side of Lee Road, joint front corners of Lots # 7 and # 8, and running thence with the line of Lot #8, S. 17-10 E. 313.8' to an iron pin in line of lot #6; thence with the line of Lot #6, N. 73-29 E. 80' to an iron pin; thence N. 13-07 W. 314' to an iron pin on Lee Road; thence with the Southern side of Lee Road, S. 73-44 W. 100' to the beginning corner.
