All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 66 and eastern one-half of lot 65, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

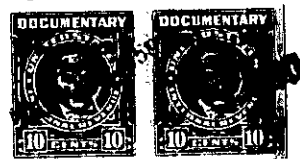
BEGINNING at an iron pin on the southern side of Bradley Boulevard at the joint front corner of lot Nos. 66 and 67 and running thence with the joint line of said lots S 37-34 E 175 feet to an iron pin on the northern side of a 20 foot alley; thence with said alley S 52-26 W 108 feet to a new point in the exact center of the rear line of lot No. 65; thence in a new line through the center of lot No. 65, N 37-34 W 175 feet to a point on the southern side of Bradley Boulevard in the exact center of the front line of lot No. 65; thence with Bradley Boulevard N 52-26 E 108 feet to the point of beginning.
