Know All Men by These Presents:

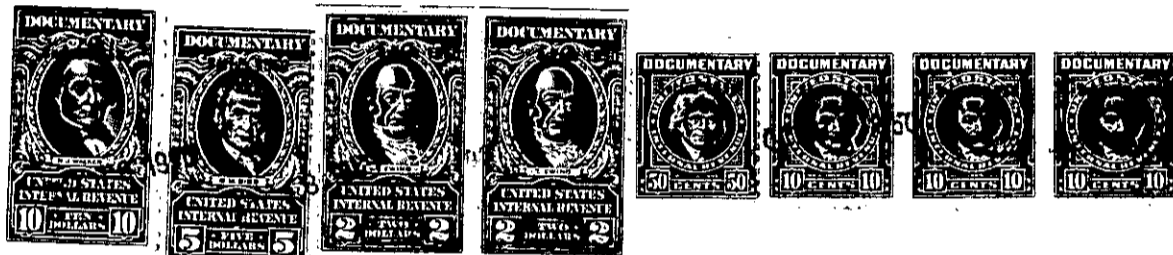
That I, Estelle L. Poliakov, in consideration of the sum of Seventeen Thousand Nine Hundred (\$17,900.00)----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Edna M. St. John

ALL That piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 189 as shown on plat recorded in Plat Book F, Pages 114 and 115 in the R. M. C. Office for Greenville County, and having according to said plat the following metes and bounds:

BEGINNING At an iron pin on the South side of Mount Vista Avenue at the joint front corner of Lots Nos. 188 and 189; thence along the joint line of said lots, S. 25-13 E. 225 feet to an iron pin at joint rear corner of Lots Nos. 188, 189, 209 and 210; thence along the joint rear line of Lots Nos. 189 and 209, N. 64-37 E. 70 feet to an iron pin, the joint rear corner of Lots Nos. 189, 190, 208 and 209; thence along the joint line of Lots Nos. 189 and 190, N. 25-13 W. 225 feet to an iron pin in the line of Mount Vista Avenue; thence along Mount Vista Avenue S. 64-37 W. 70 feet to the point of beginning.
