Know All Men by These Presents:

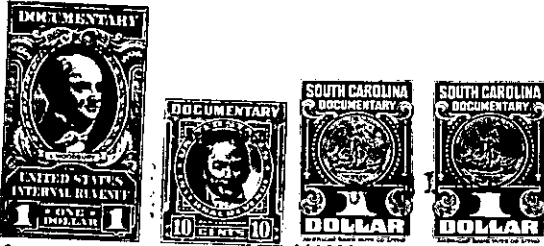
That I, Irene B. Ducker in the State aforesaid, in consideration of the sum of Eight Hundred and No/100 (\$800.00)----- DOLLARS,

Robertson and Mildred L. Robertson, their Heirs and Assigns forever,

All that lot of land in Greenville Township, Greenville County, State of South Carolina, on the Northern side of Irene Circle, near the City of Greenville, being shown as lot No. 19 on Plat of Royal Heights made by Dalton & Neves in April 1949, recorded in Plat Book W at Page 25, and described as follows:

BEGINNING at a stake on the Northern side of Irene Circle at corner of lot No. 20, and running thence with line of said lot, N. 26-07 E. 140 feet to a stake in line of lot No. 25; thence with the line of said lot, S. 63-53 E. 60 feet to a stake at corner of lot No. 18; thence with line of said lot, S. 26-07 W. 140 feet to a stake on Irene Circle; thence with the Northern side of Irene Circle, N. 63-53 W. 60 feet to the beginning corner.
