to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Roger W. Johnson, his heirs and assigns forever:

All that lot of land in Greenville County, State of South Carolina, on the Southeast side of Ridgecrest Drive, in the City of Greenville, being shown as lot No. 32 on plat of Vista Hills, recorded in Plat Book P at Page 149, and described as follows:

BEGINNING at a stake on the Southeast side of Ridgecrest Drive, 68.3 feet North-east from Wayne Street, at corner of lot No. 31 and running thence with the line of said lot, S. 39-15 E. 160 feet to a stake at corner of lot 35; thence with the line of said lot, N. 56-06 E. 80.35 feet to a stake at corner of lot 33; thence with the line of said lot, N. 39-15 W. 167.5 feet to a stake on Ridgecrest Drive; thence with the Southeast side of Ridgecrest Drive, S. 50-45 W. 80 feet to the beginning corner.

Grantee is to pay 1950 taxes.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.

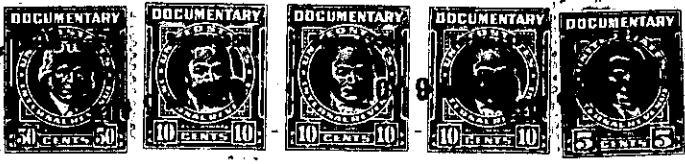
