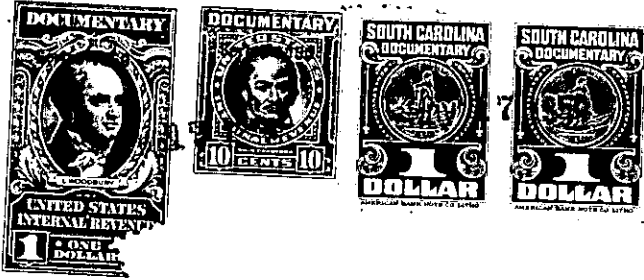

all that piece, parcel or lot of land in O'Neal Township, Greenville

County, State of South Carolina, situate about 1 1/2 miles northwest from ~~Waver~~  
Apalache Mill, lying on the South side of a surfaced road that leads  
from State Highway No. 14 at Frohawk Creek to the Gap Creek Road, and having  
the following courses and distances, according to a plat thereof made by  
J. C. Bruce, Surveyor, dated February 6th., 1950, to-wit:

BEGINNING at the intersection of the surfaced road above  
mentioned with another county road, and runs thence along said surfaced road  
S. 29.16 E. 87 feet to a bend; thence S. 36.44 E. 187 feet to a bend; thence  
S. 40.48 E. 560 feet to a bend; thence S. 28.57 E. 354.8 feet to an iron pin;  
thence leaving said road N. 85.00 W. 678 feet to an iron pin; thence N. 13.30  
E. 941 feet to an iron pin on County Road; thence along said county road  
N. 62.56 E. 200 feet to the beginning corner, containing Ten (10) acres, more  
or less, and being all of the same tract of land conveyed to me by B. H.  
burnett by deed dated the 22nd., day of March 1950 which deed is recorded
