to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ruth M. Ridgeway, her heirs and assigns forever:

All those lots of land in Butler Township, Greenville County, State of South Carolina, on the Western side of Hudson Drive, near the City of Greenville, being shown as lots 1, 2 and 3 on a plat of Hudson Acres, recorded in Plat Book Y at Page 38, and described as follows:

BEGINNING at a stake at the Southwestern corner of Old Spartanburg Road and Hudson Drive, and running thence with the Western side of Hudson Drive, S. 7-20 W. 425.1 feet to a stake at corner of lot No. 4; thence with the line of said lot, N. 82-40 W. 273 feet to a stake; thence N. 20-05 E. 386.9 feet to a stake on Old Spartanburg Road; thence with the Southern side of Old Spartanburg Road, N. 85-15 E. 193 feet to the beginning corner.

This property is conveyed subject to the restrictions recorded in Book of Deeds 416 at Page 261, and as amended by agreement dated October 16, 1950, and recorded herewith. By the amendment lots 1 and 2 have been recut to face on Hudson Drive and any residences erected thereon must face on Hudson Drive.
