Know All Men by These Presents:

That we, Robert E. Gregory and Evelyn Ann Gregory, in the State aforesaid, in consideration of the sum of Two Thousand, Seven Hundred and 45/100 (\$2,753.45 DOLLARS, and assumption of a certain mortgage hereinafter more fully described, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Robert E. and Doris F. Atkinson, their heirs and assigns,

All that piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, located on the northwest side of Blair Street (formerly Rose Street), designated as Lot # 11 on a plat of the Laurens Road sub-division, said plat being recorded in the R.T.C. Office for Greenville County in Plat Book "O" at page 116, and having according thereto, the following notes and bounds, to-wit:

BEGINNING at a point on the Northwest side of Blair Street, at the joint front corner of Lots # 11 and 13, said point being 636.7 feet from the southwest corner of the intersection of Laurens Road and Blair Street, and running thence along the line of Lot # 13 northwest 194.7 feet; thence along the line of Lot # 16 S. 61-55 W. 75 feet; thence along the line of Lot # 9 southeast 194.7 feet to the Northwest side of Blair Street; thence along said Blair Street N. 61-55 E. 75 feet to the point of beginning.

This being the same property conveyed to the grantors herein by Ralph L. Hillhouse by deed dated August 10, 1946, said deed being recorded in the R.T.C. Office for Greenville County in Deed Book 297 at page 277.

The grantee herein agrees to assume that certain mortgage executed by the grantors in favor of the Fidelity Federal Savings & Loan Association in the original amount of \$2,000.00, upon which there is a present balance due of \$1,496.55, said mortgage being recorded in the R.T.C. Office for Greenville County in Mortgage Book 301 at page 92.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

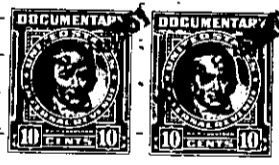
