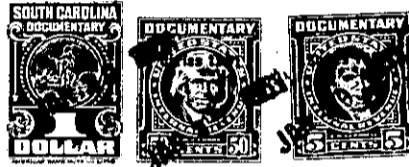
Know All Men by These Presents:

That I, T. R. Dill in the State aforesaid, in consideration of the sum of Two Hundred (\$200.00) \* \* \* \* \* DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. L. Burns,

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the Eastern side of Gridley Street, about 1 1/2 miles from the corporate limits of the City of Greenville, being a portion of Lot No. 218 as shown on plat of McCarey property, recorded in Plat Book A, at page 279, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Lot No. 218, which pin is 95 feet from Gridley Street, and running thence with the line of Lot No. 219 in an Easterly direction 109 ft. to an iron pin in the rear corner of Lot No. 202; thence with the rear line of Lot No. 202 in a Northerly direction 66 ft. to an iron pin at corner of Lot No. 217; thence with line of Lot No. 217 in a Westerly direction 109 ft. to an iron pin, which pin is located 95 feet from Gridley Street; thence in a straight line in a Southerly direction 66 ft. to an iron pin, and the point of beginning, and being a portion of Lot no. 218 conveyed to the grantor herein by Carl M. Dill by deed dated the 26th day of January, 1951 and recorded in the R. M. C. Office for Greenville County in deed volume 428 at age 13.
