KNOW ALL MEN BY THESE PRESENTS, That we, Mrs. Susan Savage and Mrs. Dorothy Rambo, in the State aforesaid, for and in consideration of the sum of Ten Dollars and other valuable considerations to us in hand paid, at and before the sealing of these presents, by Mrs. Ora T. Gibson (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents, do grant, bargain, sell and release unto the said \_\_\_\_\_

Mrs. Ora T. Gibson the two thirds (2/3) of the eastern part of Lot No. 28 of Section S of Springwood Cemetery and having the following dimensions to-wit:

N. 16-1/2', E. 8', S. 16-1/2', W. 8'

for the right of burial and cemetery purposes, and to be used exclusively for the right and purpose aforesaid, and subject to the conditions of the Charter of the City of Greenville, and all revisions thereof and amendments that may be made thereto, and also subject to the Ordinances of the City of Greenville and the rules, regulations, and by-laws of the City Council and Cemetery Committee, now in force, or which may hereafter be passed, relating to said Cemetery and the burial of the dead therein. This being the same property purchased by the said Mrs. Susan Savage and Mrs. Dorothy Rambo from the City of Greenville in March and June of 1938 and for which no deed was given since this portion of the above lot was divided into single graves and each of the Grantors purchased two single grave lots from said City.

Together with all and singular the Rights, Hereditaments and Appurtenances of said premises belonging, or in anywise incident or appertaining.

To Have and to Hold all and singular the said Premises before mentioned unto the said Mrs. Ora T. Gibson, her heirs and assigns forever; subject, however, to the limitations and conditions hereinfore imposed.

And we do hereby bind ourselves, and our heirs, executors, and administrators, to warrant and forever defend all and singular the said Premises unto the said grantee and her heirs and assigns, against us and our heirs and against every other person whomsoever lawfully claiming or to claim the same or any part thereof.
