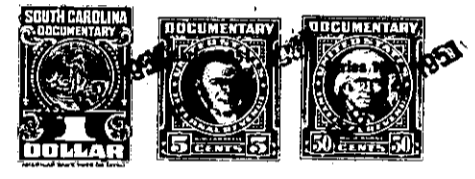

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), has (have) granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Marion P. Hindman and C. C. Hindman, Jr., herein called grantees, Lot No. 15 on plat of property of Lucy L. Hindman by W. J. Riddle, dated August 1937, recorded in Plat Book T, Page 42, from which the following description is taken:

BEGINNING at a point on the western edge of Old Chick Springs Road which is designated as the joint front corner of Lots 14 and 15, and running thence the joint line between these lots S. 79-26 W. 140' to their joint rear corner or a branch; thence running this branch in a northerly direction approximately 120' to the joint rear corner of Lots 15 and 16; thence running the joint line between these lots S. 78-21 E. 177' to their joint front corner on the western edge of the Old Chick Springs Road; thence along the western edge of this road S. 13-12 W. 50' to the beginning corner.

This lot is shown on County Tax Map 186 as Block 1 and a part of Lot 3, and is the same lot conveyed to the grantor by Lucy L. Hindman, April 11, 1950, by deed recorded in Book 406 at Page 402. March 24,

Taxes have been apportioned and are to be paid by the grantee for the year 1951.
