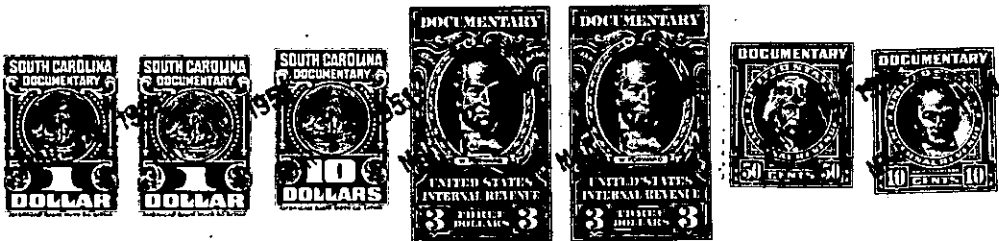
Know All Men by These Presents:

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said **Robert Limuel Smith, his heirs and assigns forever**

All that certain piece, parcel or lot of land, situate, lying and being in the City and County of Greenville, State of South Carolina, being known and designated as a portion of Lots Nos. 77 and 76, according to a plat of Shannon Terrace, plat made by H. E. Brockman, January 3, 1930, recorded in the R. M. C. Office for Greenville County in Plat Book L, at page 91 and having; according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southeastern side of Brookview Circle, which iron pin is N. 39-30 E. 54 feet from the joint front corner of Lots Nos. 75 and 76, and which iron pin is the new joint front corner of Lots Nos. 76 and 77; and running thence along the southeastern side of Brookview Circle, N. 39-30 E. 66 feet to an iron pin; thence S. 37-45 W. 160.8 feet to an iron pin; thence S. 28-24 W. 35 feet to an iron pin, the new rear corner of Lots Nos. 76 and 77; thence N. 48-40 W. 163.4 feet to an iron pin at the point of beginning.
