All that certain piece, parcel or lot of land in Greenville Township, Greenville County, state of South Carolina, on Leone Avenue, being known and designated as lot No. 7 and a portion of lot No. 6, Block D, of the J. Ed Means property shown on plat thereof made by W. J. Riddle, Surveyor, January 1940 recorded in the R. M. C. Office for Greenville County in plat book J pages 186 and 187 and having according to said plat the following metes and bounds, to-wit:

Beginning at a stake on the northeast side of Leone Avenue, 169 feet from the southeast corner of Leone Avenue and Eva Street and running thence N. 49-30 E. 175 feet to a stake in line of lot No. 4; thence with the rear line of lot No. 4 & 3, S. 40-30 E. 206.3 feet to the rear corner of lot No. 8; thence with the line of said lot S. 49-30 W. 175 feet to an iron pin on the northeast side of Leone Avenue; thence with the northeast side of said street N. 40-30 W. 206.3 feet to the point of beginning.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

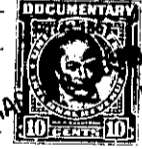
