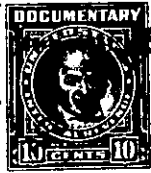

me in hand paid at and before the sealing of these presents by the grantee(s) hereinafter named (the receipt of which
is hereby acknowledged), have granted, sold and released, and by these presents do grant, sell and release unto
Joe K. Smith and Haskell K. Smith all that piece,
parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina,
situate on the northern side of Lee Road, and being shown as Lots Numbers 56, 57, and 58
of Block D on plat of Buena Vista, recorded in Plat Book W at pages 11 and 29.

For restrictions affecting this property see Deed Book 379 at page 230.

Grantee to pay 1951 tax.

This deed is made subject to restrictions applicable to Buena Vista and recorded in the R. M. C. Office for
Greenville County, S. C., in deed Book 379, page 230, and further subject to utility easements of record.

ing, or in anywise incident or appertaining.

tors to warrant and forever defend all and singular the said Premises unto the said Grantee(s) hereinabove named, and
their heirs and assigns against himself and his heirs and assigns, and against every
person whomsoever lawfully claiming or to claim the same or any part thereof.
