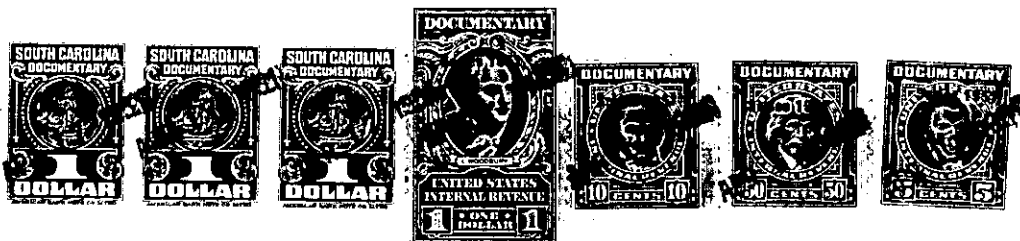

Hall, his heirs and assigns, forever:

All that lot of land situate on the Southwest side of South Carolina State Highway No. 291, in Butler Township, Greenville County, State of South Carolina, shown as Lot 22 on plat of Holmes Acres, made by Dalton & Neves, Engineers, February 1951, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "Z", at page 1, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of South Carolina State Highway No. 291, at joint front corner of Lots 21 and 22, and running thence along the line of Lot 21, S 49-48 W 165 feet to an iron pin on the Northeast edge of a screen area; thence along said screen area, S 30-44 E 91.24 feet to an iron pin; thence along the line of Lot 23, N 49-48 E 180 feet to an iron pin on the Southwest side of South Carolina State Highway No. 291; thence along the Southwest side of said highway, N 40-12 W 90 feet to the beginning corner.
