Know All Men by These Presents:

That I, Eliza T. Looper in the State aforesaid, in consideration of the sum of TEN & NO/100 DOLLARS, and other valuable considerations to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Malcolm W. Carter, his heirs and assigns forever

All that certain lot of land in Greenville Township, Greenville County, South Carolina, known and designated as Lot 105 of the subdivision of the property of Eliza T. Looper as shown by a plat made by R. E. Dalton as revised July 1947. Said lot has the following metes and bounds:

BEGINNING on the south side of Douglas Street at the corner of Lot 106 which point is 268.22 feet east of Washington Avenue intersection with Douglas Street; thence with the south side of Douglas Street N. 72-30 E. 50 feet to corner of Lot 104; thence with lot 104 S. 18-40 E. 154.7 feet to the common corner of Lots 75, 76, and 104; thence with the rear line of Lot 75, S. 71-20 W. 50 feet to the rear corner of Lot 106; thence with line of Lot 106 northwesterly 155.8 feet to the beginning corner.

Since the plat of said property was drawn Lots 104 and 76 have been made into a street to form the extension of Keith Avenue across Wilson Street over to Douglas Street so that Lot No. 105 now lies on the corner of Keith Avenue and Douglas Street.
