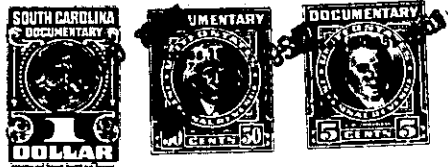
That J. H. Bruce in the State aforesaid,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Virginia Bruce Allen, her heirs and assigns, all that certain piece, parcel or lot of land situate lying and being on the Southeast side of Crosby Circle, in Gantt Township, in Greenville County, South Carolina, being shown as Lot No. 139 on plat of Paramount Park, made by Piedmont Engineering Service, July 1949, recorded in Plat Book W, page 57, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeasterly side of Crosby Circle, joint front corner Lots Nos. 138 and 139 and running thence with the line of Lot No. 138 S. 26-00 E. 150 feet to an iron pin; thence S. 64-00 W. 70 feet to an iron pin; thence with the line of Lot No. 140 N. 27-00 W. 150 feet to an iron pin on the Southeasterly side of Crosby Circle; thence along the Southeasterly side of Crosby Circle N. 64-00 E. 70 feet to an iron pin, the point of beginning.
