Norris, his Heirs and Assigns:

All of my undivided one-half interest in and to all that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being in the Sixth Ward in the City of Greenville, South Carolina, and being designated as a portion of lots 8 and 9 of the Property of Charlotte M. Goldsmith on plat made by R. E. Dalton recorded in the RMC Office for Greenville County, S. C., in Plat Book "F", page 47 and having according to a recent survey made by Dalton & Neves, February, 1951, the following metes and bounds, to-wit:
