to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Charles A. Murrell and Agnes Louise Murrell their heirs and assigns forever:

ALL that piece parcel or lot of land being known and designated as Lot No. 39 of Conestee as shown by a Plat thereof made by Madison H. Woodward, Engineer; said Lot having the courses, distances, metes and bounds to-wit:

BEGINNING at an iron pin at corner of Lot No. 40 and running thence along the line of said Lot No. 40, S. 47-46 E. 200 feet to iron pin at back corner of Lot No. 40; thence N. 68-32 W. 213 feet to iron pin on Sixth Street; thence with the line of Sixth Street N. 42-14 E. 67.8 feet to point of beginning.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
