to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. R. Mansfield and Eugenia Mansfield

All those two certain lots of land in Chick Springs Township, Greenville County, South Carolina, on the west side of Cardinal Drive, being known and designated as Lots Nos. 45 and 46 of Cardinal Park, property of Oscar L. Ayers, as shown on plat made by R. K. Campbell, April 24, 1949, and recorded in the R. M. C. Office for Greenville County in Plat Book W, page 27, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on the west side of Cardinal Park, at corner of Lot No. 44, and running thence with line of Lot No. 44, S. 64-02 W. 139.3 feet to iron pin; thence S. 25-58 E. 140 feet to iron pin at corner of Lot No. 47; thence with line of Lot No. 47, N. 64-02 E. 139.3 feet to iron pin on the west side of Cardinal Drive; and thence with the west side of Cardinal Drive, N. 25-58 W. 140 feet to the beginning corner, being a portion of the same conveyed to me by Martha J. This property is conveyed subject to the following restrictions and conditions: Said property is to be used for residential purposes only; no residence to cost less than \$5,000.00; no building to be erected nearer than 30 feet from the street on which it faces; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no part of said property to be sold, rented or otherwise disposed of to any person of African descent; property conveyed subject to recorded rights-of-way; no residence to be built on any lot or portion thereof, unless said lot has 50 feet or more street frontage.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
