to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Furman C. Smith, his heirs and assigns, forever:

All those lots of land situate on the West side of Mallory Street, in Butler Township, in Greenville County, State of South Carolina, shown as Lots 35 and 37, on plat of Holmes Acres, made by Dalton & Neves, Engineers, February 1951, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "Z", at page 1, and having, according to said plat, the following metes and bounds, to-wit:

Lot 35: BEGINNING at an iron pin on the West side of Mallory Street, at joint front corner of Lots 35 and 36, and running thence along the line of Lot 36, N 79-12 W 172.4 feet to an iron pin; thence S 5-01 W 102.5 feet to an iron pin on the North side of Holly Street; thence along the North side of Holly Street, S 83-26 E 132.5 feet to an iron pin; thence with the curve of Holly Street (the chord being N 53-41 E 44 feet) to an iron pin on the West side of Mallory Street; thence along the West side of Mallory Street, N 10-48 E 60 feet to the beginning corner.

Lot 37: BEGINNING at an iron pin on the West side of Mallory Street, at joint front corner of Lots 36 and 37, and running thence along the line of Lot 36, N 79-12 W 181 feet to an iron pin; thence N 5-01 E 90.7 feet to an iron pin; thence along the line of Lot 38, S 77-40 E 189.8 feet to an iron pin on the West side of Mallory Street; thence along the West side of Mallory Street, S 10-48 W 85 feet to the beginning corner.

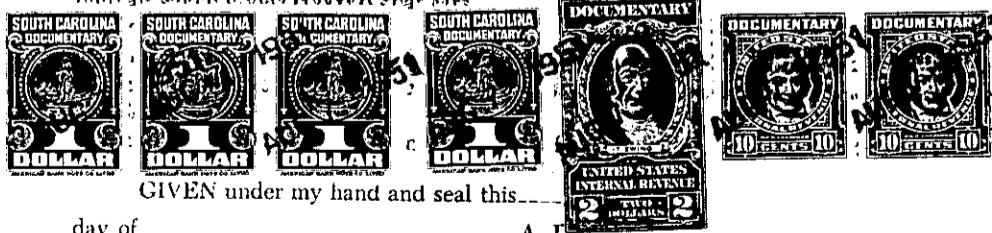
