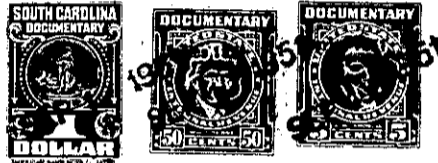
Know All Men by These Presents:

That I, Thomas Earl Thompson, - - - - - in the State aforesaid, in consideration of the sum of Two Hundred Fifty and No/100 - - - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee, Robert L. Mosteller; his Heirs and Assigns forever,

ALL that certain piece, parcel or lot of lard situate, lying and being in the State and County aforesaid, O'Neal Township, about six miles north from Greer, lying on the East side of the Mt. Lebanon Road, being bounded on the north by other lands of myself, on the east by lands of, or of, Lloyd Johnson, on the south by lands of Bruce and on the west by the said road, and being a part of the same land that was conveyed to me by deed recorded in the office of the R. M. C. for said county in Deed Book 441 at page 201, and having the following courses and distances, to wit:- 281

Beginning on a stake or iron pin, the northwest rear corner of the Johnson lot, and runs thence with the same course as the rear line of the said Johnson lot, N. 86-00 W. 237.4 feet to a nail and stopper in the center of the said Mt. Lebanon Road (stake back on line at 64 feet); thence with the center of the said road, S. 13-00 W. 211.2 feet to a nail and stopper in the center of the said road and on the Bruce line; thence with the said line and with another road that leads east, S. 86-00 E. 271.4 feet to a point in the said road, joint corner of the Johnson lot; thence with the Johnson line, N. 4-00 E. 208.4 feet to the beginning corner, and containing One and Twenty Three One-hundredths (1.23) acres, more or less.
