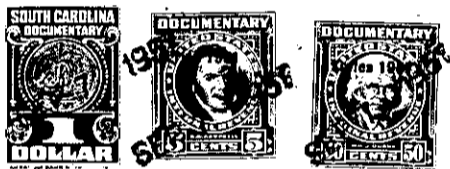

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto H. P. Asay, Jr., and T. G. Crymes, Jr.; their heirs and assigns: All that piece, parcel or lot of land, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 191, Pleasant Valley Subdivision, as per plat thereof recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book P, page 114, and having, according to said plat, the following metes and bounds, to-wit:
