M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

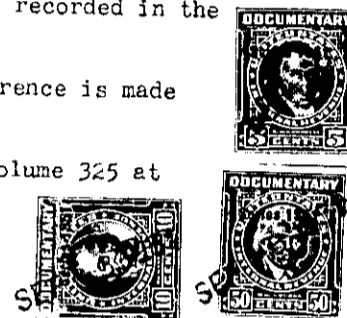
BEGINNING at an iron pin on the Southern side of Brookside Circle at the southeastern corner of the intersection of Brookside Circle and Beverly Lane and running thence with the Southern side of Brookside Circle N. 52-26 E. 75 feet to an iron pin, joint front corner of Lot Nos. 117 and 118; thence with the joint line of said lots S. 37-34 W. 182.5 feet to an iron pin, joint rear corner of Lot Nos. 117, 118, 96 and 97; thence with the joint rear line of lots 97 and 117 S. 52-26 W. 75 feet to an iron pin on the eastern side of Beverly Lane; thence with Beverly Lane N. 37-34 W. 182.5 feet to the point of beginning and being Lot No. 117.

This being a portion of the property conveyed to the grantors by deed recorded in the R. M. C. Office for Greenville County in Volume 345 at page 159.
