All those two certain pieces, parcels or lots of land situate on the Northwest side of Green Acre Road, in the County and State aforesaid, and being more particularly described as follows, as shown on plat of property of Emma M. Webster, made by Dalton & Neves, Engineers, May, 1942, being lots Nos. 6 and 7 as shown on the above-referred to plat.

BEGINNING at an iron pin on the Northwest side of Green Acre Road, joint corner of Lots Nos. 5 and 6, and running thence N. 58-30 W. 150 feet to an iron pin, rear joint corner of Lots Nos. 5 and 6, thence S. 31-30 W. 120 feet to an iron pin; thence S. 58-30 E. 150 feet to an iron pin on Green Acre Road; thence along Green Acre Road, N. 31-30 E. 120 feet to the beginning corner.
