Know All Men by These Presents:

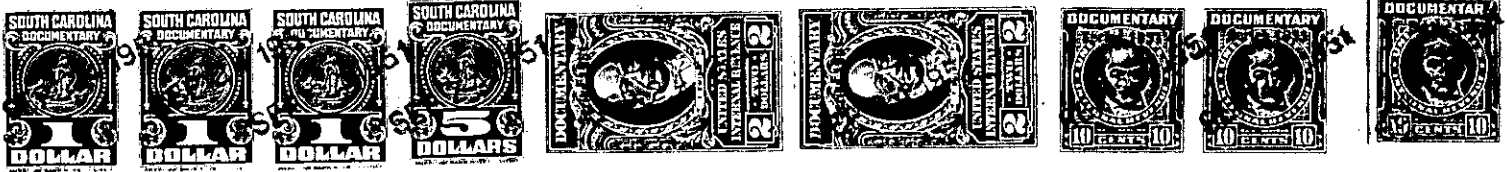
That I, Edward D. Dobson in the State aforesaid, in consideration of the sum of Thirty-six Hundred (\$3600.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) C.L. Belue (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C.L. Belue and his heirs and assigns:

All that certain parcel or lot of land situated on the East side of State Highway No. 14, leading from Greer to Landrum, about two miles Northward from Greer, in Oneal Township, Greenville County, State of South Carolina, designated as Lot No. 1 of the property of Ervin Forrester, according to survey and plat thereof by H.S. Brockman, Surveyor, dated May 24, 1939, and having the following courses and distances, to wit:

Beginning at the center of the culvert in said highway, and running thence N. 60.00 E. 237.5 feet to a stake; thence S. 81.20 E. 241 feet to an iron pin in abandoned road; thence N. 27.57 W. 260.4 feet to corner of Lot No. 2; thence S. 76.30 W. 383 feet to center of said highway; thence along said highway, S. 1.30 E. 35 feet to point in highway; thence S. 10.40 E. 100 feet to point in highway; thence S. 17.40 E. 100 feet to the beginning corner.
