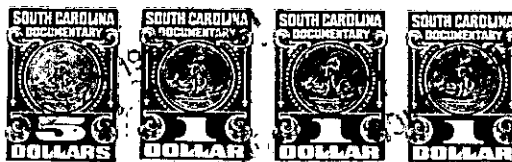


STATE OF SOUTH CAROLINA, GREENVILLE COUNTY



Given All Men by These Presents: R.M.C.

That David G. Traxler in the State aforesaid in consideration of the sum of - - - - Four Thousand - - - - and No/100 (\$4,000.00) - - - -DOLLARS. and assumption of mortgage described below

to the grantors in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged). have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Jerome J. Huff, his heirs and assigns, all that piece, parcel or lot of land situate, lying and begin on the North side of Pacific Avenue, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 325, Pleasant Valley Subdivision, as per plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book P, page 114 and having, according to said plat, the following metes and bounds to wit:

BEGINNING at an iron pin on the North side of Pacific Avenue, joint front corner Lots Nos. 324 and 325, which iron pin is 297.3 feet West of iron pin in the Northwest intersection of Phoenix and Pacific Avenues, and running thence N. 0-08 W. 147 feet to an iron pin, joint rear corner Lots Nos. 324, 325, 316, and 317; thence S. 89-52 W. 60 feet to an iron pin, joint rear corner Lots Nos. 325, 326, 315 and 316; thence S. 0-08 E. 147 feet to an iron pin on the North side of Pacific Avenue; thence along the North side of Pacific Avenue N. 89-52 E. 60 feet to an iron pin, the point of beginning.

Grantee to pay 1951 taxes.

As a part of the consideration hereof, the grantee agrees to assume and pay, according to its terms, that certain note and mortgage given by David G. Traxler to The First National Bank of Greenville, S. C., in the sum of \$3,500.00; said mortgage being recorded in the R. M. C. Office for Greenville County, South Carolina, in Mortgages Volume 498, page 223.

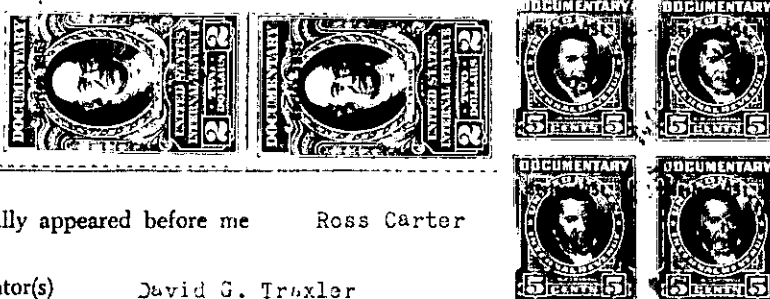
