That Else Muller in the State aforesaid, in consideration of the sum of One And No/100 (\$1.00) ----- DOLLARS, and love and affection to my husband, the grantee, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Egon Waldemar Muller, his heirs and assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the north side of East Earle Street in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot 12, Section F, on plat of Stone Land Company, recorded in the R. M. C. office for Greenville County in Plat Book "A", at pages 337 through 345 (also recorded in Plat Book "K", at pages 277 and 278), and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of East Earle Street, at joint front corner of Lots 11 and 12, Section F, and running thence along the line of Lot 11, in a Northerly direction, 174.6 feet, more or less, to an iron pin on the South side of Garraux Street (formerly known as Swiss Avenue); thence along the South side of Garraux Street S 66-15 & 65 feet 3 inches to an iron pin at joint rear corner of Lots 12 and 10; thence with the line of Lot 13, in a Southerly direction, 167.5 feet, more or less, to an iron pin on the North side of East Earle Street; thence along the north side of East Earle Street, West-erly 65 feet 4 inches to the beginning corner.
