to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

MARYANN PHILLIPS, her heirs and assigns forever,

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, known and designated as Lot No. 15, together with the improvements situate thereon, of the Providence Subdivision according to plat of F. G. Rogers, Surveyor, dated May 27, 1910 and recorded in the RMC Office for Greenville County, S. C. in Plat Book "A", at page 411 and having the following metes and bounds, to wit:

BEGINNING at a pin on the North side of the Easley Bridge Road, corner of Lot No. 14 and running thence in a Northerly direction with line of Lots Nos. 14 and 13 as originally shown on said plat, 77 feet to a pin on an alley; thence in a Westerly direction with said alley, 20 feet to corner of Lot No. 16; thence with line of Lot No. 16 in a Southerly direction 73 feet to pin on North side of Easley Bridge Road; thence with said Easley Bridge Road, South 85 1/2 East 20 feet to the beginning corner.

The above lot is subject to an easement or right-of-way for an alley ten (10) feet wide at the rear of said lot.
