to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said M. W. Fore, his heirs and assigns forever:

ALL that piece, parcel or lot of land being known and designated as Lot No. 135 of Conestee as shown by a Plat thereof, made by Madison H. Woodward, Engineer; said Lot having the courses, distances, metes and bounds to-wit:

BEGINNING at an iron pin on East Pine Lake Circle and running thence N. 50-25 W. 97.5 feet to an iron pin; thence at an angle and still with Pine Lake Circle and running thence along Pine Lake Circle S. 22-19 W. 300 feet to iron pin; thence still with Pine Lake Circle S. 15-32 W. 49.8 feet to iron pin at corner of Lot No. 134; thence along the line of said Lot No. 134 S. 89-31 E. 199.7 feet to iron pin at rear of Lot No. 136; thence with the line of said Lot No. 136 N. 0-29 E. 265 feet to iron pin at point of beginning.

No residence to cost less than Two Thousand (\$2,000.00) Dollars, shall be erected on said lot nearer than twenty-five (25) feet to the frontline, and no residence shall be built on any lot unless said lot has fifty (50) feet, or more, frontage.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
