in consideration of the sum of Six Thousand One Hundred Eighty and No/100 - (6180.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Perry V. Haymes and Helen S. Haymes:- All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville County, State of South Carolina, located on the east side of State Highway # 2, just north of the Town of Simpsonville, being known and designated as lot # 4 on a plat of property of the Estate of F. M. Todd, said subdivision known as "Roland Heights", plat thereof being on record in the Greenville County R. M. C. Office in Flat Book "S" at page 34 and lot being more fully described as follows:

Beginning at an iron pin on east side of State Highway # 2, also U. S. Highway # 276, joint corner with lot # 3, and running thence along line of lot # 3 N. 52-16 E. 175 ft. to iron pin on line of lot # 36; thence along line of lot # 36, N. 35-09 W. 87.5 ft. to iron pin, joint corner of lots 5, 25 and 36; thence along line of lot # 5, S. 52-16 W. 175 ft. to iron pin on east side of Highway; thence along Highway S. 35-09 E. 87.5 ft. to the beginning corner, and being one of two lots conveyed to Geo. Webb by H. W. Abbott by deed dated November 3, 1950 and recorded in Vol. 422 at page 530, R. M. C. Office for Greenville County.

The above lot is conveyed subject to the right of way of U. S. Highway # 276 (State Highway # 2) and subject to the reservations and restrictions in an instrument affecting all of the property in the mentioned subdivision as recorded in Deed Book 419, page 331, and reference is here made to that instrument for the terms and conditions of the restrictions and limitations.
