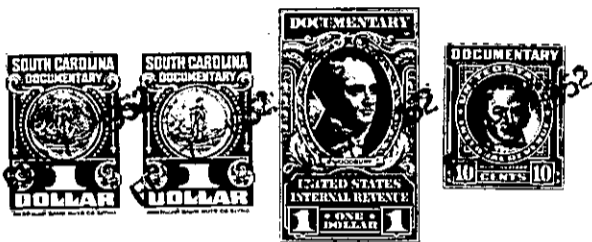
Know All Men by These Presents:

Township, Greenville County, and in the state of South Carolina having the following metes and bounds and courses and distances:

Davis line and running thence S. 62.30 E. 14.56 chs. to a stake on the north side of the Lester Bridge Road; thence S. 88.45 E. 5.00 chs. to a point in said road; thence N. 88.30 E. 6.07 chs. to a point in said road; thence S. 71.30 E. 7.32 chs. to a stake on the T.
