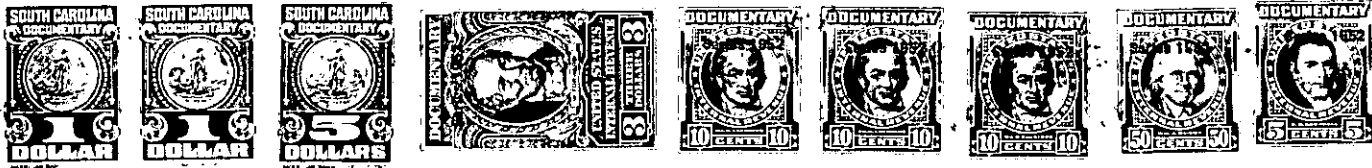

Martin, her Heirs and Assigns forever,

All that lot of land in Greenville Township, Greenville County, State of South Carolina, on the Northern side of Green Avenue Extension, being known and designated as Lot No. 19 of Block A as shown on Plat of the property of Melrose, recorded in Plat Book A at Page 157, and described as follows:

BEGINNING at a point on the Northern side of Green Avenue extension at the joint front corner of Lots Nos. 18 and 19, and running thence with the joint line of said lots in a Northwesterly direction, 208.8 feet to a point in Southern Railway Right-of-Way; thence along said Right-of-way in a Southwesterly direction, 50 feet to a point at the joint rear corner of Lots Nos. 19 and 20; thence with the joint line of said lots in a Southeasterly direction, 217.4 feet to a point on the Northern side of Green Avenue Extension; thence with said Extension in a Northeasterly direction, 50 feet to the point of beginning.
