Know All Men by These Presents:

That We, N. L. Langston and Ray Wilson in the State aforesaid, in consideration of the sum of Two Thousand and No/100 (\$2000.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Wilhelmenia S. Scott, her Heirs and Assigns forever,

All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, on the Southeastern side of Super-Highway No. 29, being known and designated as Lot No. 207 on Plat of the Property of Robert J. Edwards, made by Dalton & Neves in May 1951, and described as follows:

BEGINNING at an iron pin on the Southeastern side of Super-Highway at the joint front corner of Lots Nos. 206 and 207, and running thence with the line of Lot No. 206, S. 47 E. 325 feet to an iron pin at the rear corner of Lot No. 250; thence with the rear line of Lot No. 250, N. 43 E. 100 feet to an iron pin at the rear corner of Lot No. 208; thence with the line of Lot No. 208, N. 47 W. 325 feet to iron pin on right-of-way of Super-Highway No. 29; thence with the Southeastern side of said Highway, S. 43 W. 100 feet to the point of beginning.

It is distinctly understood and agreed that this conveyance is made subject to the following restrictions which are for the mutual benefit of the Grantors, Grantee and other persons owning lots on the same Plat, and are expressly made a part of the consideration thereof:

- (1) Said lot shall be used for residential purposes only.
(2) No residence shall be constructed thereon containing less than 1200 square feet of floor space, exclusive of porches and breeze-ways.
(3) No garage apartments shall be constructed upon said lot.
(4) No building of any kind, or residence, shall be constructed nearer than 50 feet from the front line of said lot.

Said premises being the same conveyed to the Grantors by Robert J. Edwards, by deed to be recorded.

Grantee to pay 1952 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

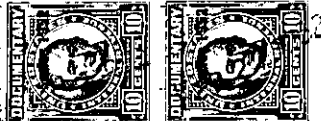
