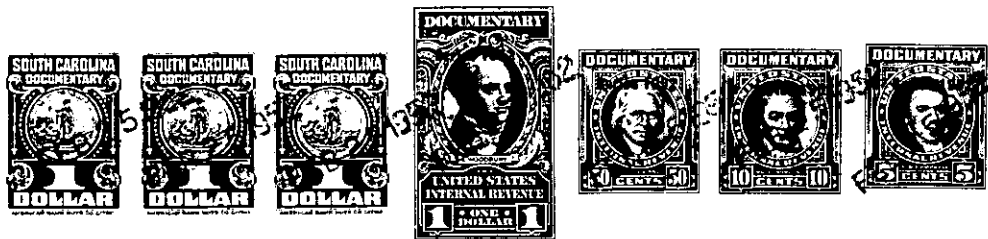
That I, Liza Patterson Harris ( formerly Liza Patterson ) in the State aforesaid,
