All that certain lot of land in Chick Springs Township, Greenville County, South Carolina, on the northeast side of Cardinal Drive, being known and designated as Lot No. 36 and one-half of Lot No. 37 of Cardinal Park, property of Oscar L. Ayers, as shown on plat made by R. K. Campbell, April 24, 1949, and recorded in the R. K. C. Office for Greenville County in Plat Book 2, page 27, and having the following notes and bounds according to said plat:

Beginning at an iron pin on the north east side of Cardinal Drive, at corner of Lot No. 35, and running thence with line of Lot No. 35, N. 65-07 W. 111.6 feet to iron pin at joint corner of Lots Nos. 13, 14, 35 and 36; thence with the rear line of Lots Nos. 12 and 13, N. 24-04 W. 105 feet to stake; thence S. 65-07 W. 129.3 feet to stake on the northeast side of Cardinal Drive; and thence with Cardinal Drive, S. 25-58 E. 105 feet to beginning corner, being a portion of the same conveyed to me by Martha J. Edwards by deed dated February 17, 1948, and recorded in Book 306, page 397.

This property is conveyed subject to the following restrictions and conditions: said property to be used for residential purposes only; no building to cost less than \$5,000.00; no building to be erected nearer than 50 feet from the street on which it faces; no outside toilets permitted and same to be disposed of by approved public works; no part of said property to be sold, rented or otherwise disposed of to any person of African descent; property conveyed subject to recorded rights-of-way; no residence to be built on any lot or portion thereof, unless said lot has 50 feet or more street frontage.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

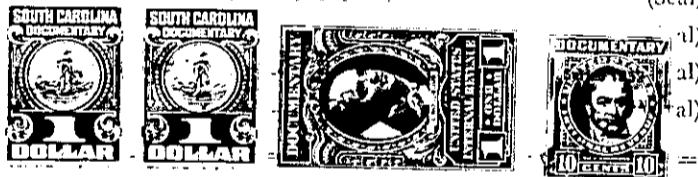
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.
