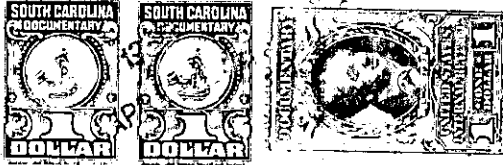

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

A.H. Campbell, Grantee, and his heirs and assigns forever, All of that piece, parcel or lot of land in Highland Township, Greenville County, South Carolina, lying on the south side of of a paved road that leads from the Lenoah School by Camp Creek to Tigerville, near the said Lenoah Public School, being all of Tract No. 14 on a Plat of the W. W. Davis Estate Property made by H. L. Dunahoo, Surveyor, dated January 23rd, 1947, and having the following courses and distances:

BEGINNING on an iron pin, corner with Mrs. Cora H. Odom's land, and being the southwestern corner of the tract herein conveyed, and runs fence with Mrs. Odom's line N. 36.15 E. 300 feet to a stake on the South edge of said Road; thence with the southern edge of said Road in a southeasterly direction 354 feet to a stake, corner of lot No. 15; thence with the line of lot No. 15 S. 42.10 W. 480 feet to a stake; thence N. 25.30 W. 243 feet to a stake; thence N. 34.30 W. 100 feet to the beginning corner, and containing three and one-tenth (3.1) acres, more or less, and being all of the same tract of land conveyed to me by Lora L.
