

The above tract of land was conveyed to the Grantor by deed of Ellis C. Johnson, dated June 6, 1923, recorded in the said R. M. C. Office in Deed Book 85, at pages 312 and 313.

PARCEL - 30: All that certain tract of land in Cleveland Township, Greenville County, State of South Carolina, containing 240 acres, more or less, lying and being on the waters of Gap Creek, branch waters of Middle Saluda River, bounded on the East by lands of the Grantor described under Parcel 29 above, shown on plat of said property for the Grantor prepared by Howard Wiswall, C.
