to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ernest Willard Goodnough, his heirs and assigns, all that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 3, as shown on plat of W. P. and Mary M. Hall, by W. N. Willis, Engineer, dated April 11, 1951, recorded in the R. M. C.
