to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Ollie M. Batson, her heirs and assigns forever:

All that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, lying and being on the Eastern side of Rowley Street and being known and designated as Lot No. 11, Section H of property of Stone Land Company, as shown on a plat thereof recorded in the R.M.C. Office for Greenville County in Plat Book K, Page 277 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the Eastern side of Rowley Street, joint front corner Lots 9 & 11 and running thence with line of Lot 9, S. 71-50 E. 192 feet 7 inches to a point joint rear corner Lots 9, 10, 11 & 12; thence with line of Lot 12 S. 20-19 W. 55 feet to a point joint rear corner Lots 11, 12, 13 & 14; thence with line of Lot 13, N. 71-50 W. 192 feet 7 inches to a point on the Eastern side of Rowley Street joint front corner Lots 11 & 13; thence with Rowley Street N. 20-19 E. 55 feet to the beginning corner.

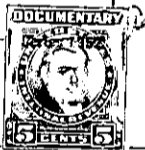
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.
