A. Carson, his heirs and assigns forever:

All That lot of Land in Greenville County, State of South Carolina, in the City of Greenville, being known and designated as Lot No. 67, Block B, as shown on a plan of University Heights, as revised, recorded in Plat Book 23 at Page 21, and later more particularly described according to said plat as follows:

BEING at an iron pin on the east side of Corinne Drive, joint front corner of lots 68 and 69, and running thence with the joint line of said lots, S. 56-37 E. 21.1 feet to an iron pin in rear corner of lot 8; thence with rear line of said lot, S. 31-27 E. 100 feet to an iron pin, joint rear corner of lots 68 and 70; thence with joint line of said lots, S. 56-37 E. 212.4 feet to an iron pin in east side of Corinne Drive; thence with said drive, S. 21-23 E. 100 feet to the point of beginning.

This property is conveyed subject to the following restrictions:

- 1. That this property shall be used for residential purposes only.
2. No house shall be constructed on said premises at a cost of less than \$10,000.
3. The lot described above shall not be recut or resubdivided.
4. Any construction on this lot shall be set back a total of 50 feet from the front lot line.
