

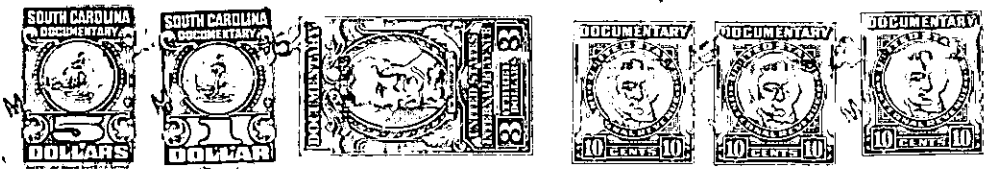
STATE OF SOUTH CAROLINA, GREENVILLE COUNTY

C., on which there is a balance due of \$1,187.64.
