to the grantor(s) in hand paid at and before the sealing of these presents by the grantees (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Robert J. Schaffer and Hannah B. Schaffer, their heirs and assigns forever.

All that lot of land situate on the southeast side of Bradley Boulevard, in the City of Greenville, in Greenville County, State of South Carolina, shown as Lot No. 66 and the northeast one-half of Lot No. 65, on plat of University Park, made by Dalton & Neves, Engineers, November 1946, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "P", at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of Bradley Boulevard, at joint front corner of Lots 66 and 67, and running thence along the line of Lot 67, S. 37-34 E. 175 feet to an iron pin on the northwest edge of a 20-foot alley; thence along the northwest edge of said alley, S. 52-26 W. 108 feet to an iron pin in the center of the rear line of Lot 65; thence through the center of Lot No. 65, N. 37-34 W. 175 feet to an iron pin on the southeast side of Bradley Boulevard in the center of the front line of Lot No. 65; thence along the southeast side of Bradley Boulevard, N. 52-26 E. 108 feet to the beginning corner.
