All of that certain piece, parcel, or lot of land, with improvements thereon, on the northeast side of Maryland Avenue, near the City of Greenville, S. C., being shown as Lot No. 14, on map number 4 of property of Talmer Cordell recorded in the R. M. C. Office for Greenville County in Plat Book X, at page 55, and having the following metes and bounds according to said plat:
