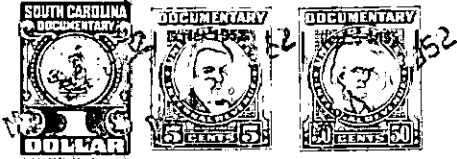
That I, J. Frank Williams, in the State aforesaid.
