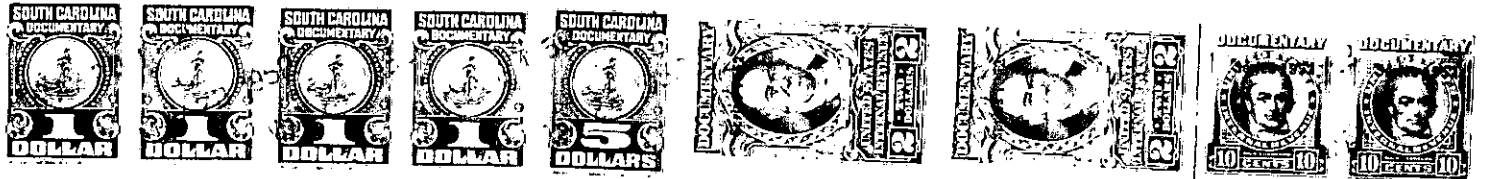
Know All Men by These Presents:

That I, W. S. Bates in consideration of the sum of Four Thousand Five Hundred (\$4,500.00) \* \* \* \* \* DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ernest L. DeShields,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, and about two miles West of the City of Greenville, and on the Northeast side of Leone Street and designated as Lots nos. 8 and 9, on a plat of subdivision made by P. E. Dalton, Engineer, said plat dated September 12, 1946 and recorded in Plat Book "F" at page 254, P. M. C. Office for Greenville County, and according to the record of said plats the following to-wit:

BEGINNING at a point on the Northeast side of Leone Street, which point is 100 feet from an iron pipe at the Northeast corner of intersection of Leone Street and New Cut Road, and at the corner corners of Lots nos. 6 and 7, on Leone Street, and running thence N. 49-30 E. 175 feet to a stake, common corners of Lots 6 and 7; thence South along the boundary line between Lots 6 and 7, S. 89-30 W. 100 feet to a stake, common corners of Lots 8, 9, 10 and 11; thence along the boundary line between lots 9 and 10, S. 49-30 W. 175 feet to an iron pin on the Northeast side of Leone Street, common corners of lots nos. 8 and 10; thence with Leone Street, S. 49-30 E. 150 feet to the point and place of beginning, and all the said tract of land conveyed to the grantor herein by Fannie Voyles by deed dated the 17th day of October, 1946 and recorded in the P. M. C. Office for Greenville County in Book volume 300 at page 140.



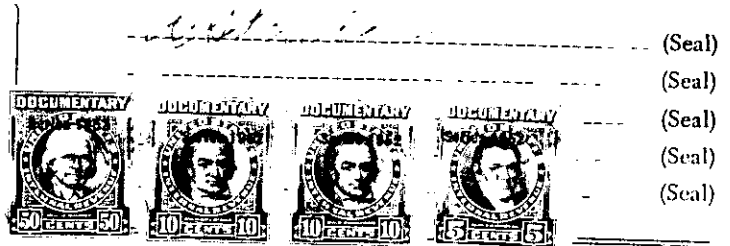
