to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Christine Keeler McCarter, her Heirs and Assigns forever, all that certain piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, being known and designated as lot No. 100 on a Map of Avalon Estates, recorded in the RMC Office for Greenville County in Plat Book "S", page 89, and having, according to said Map, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Cabler Street, joint corner of lots Nos. 46 and 100, and running thence with the rear line of lots Nos. 46, 47 and 48, S. 48-42 E., 226.2 feet to an iron pin in rear line of lot No. 97; thence N. 50-23 W., 80.2 feet to an iron pin, joint corner of lots Nos. 99 and 100; thence with line of lot No. 99, N. 48-42 W., 172.5 feet to an iron pin on the South side of Cabler Street; thence with Cabler Street, S. 41-26 W., 60 feet to an iron pin, the beginning corner. GRANTEE to pay 1952 taxes.

The above property is sold subject to the following restrictions: Said property shall not be sold, rented or otherwise disposed of to any negro or person of African descent; said property to be used for residential purposes only; no residence costing less than \$5,000.00 shall be erected on said lot; no residence or other building shall be erected on said lot nearer than 25 feet to Cabler Street
