Henson, his heirs and assigns, all that piece, parcel or lot of land situate, lying and being on the Northerly side of Pisgah Drive, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 56, Block D, Paris Heights, as per plat thereof recorded in the R. L. C. Office for Greenville County, South Carolina, in Plat Book Y, page 65, and having, according to said plat, the following metes and bounds, to wit:
