Know All Men by These Presents:

That We, J. D. Hood and Grace B. Hood in the State aforesaid, in consideration of the sum of Five Hundred (\$500.00) \* \* \* \* \* DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Will Hall,

All that certain piece, parcel or lot of land situate, lying and being in Greenville, County, containing 0.79 acre, more or less, and being known and designated as Lot Number Five of the property of J. D. Hood according to plat made by W. J. Riddle, Surveyor, June 12, 1952, said plat not yet recorded, and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the South side of county road, joint corner of lots four and five, and running along the line of lot number 4, S. 13-38 W. 285 feet to iron pin at joint rear corner of lots four and five; thence S. 83-35 W. 111.8 feet to iron pin joint rear corner of lots five and six; thence along the line of lot number six, N. 8- 54 E. 297 feet to an iron pin on the South side of county road; thence along the right-of-way of said county road S. 88-48 E. 131.5 feet to an iron pin the beginning corner, and being a portion of the property conveyed to the grantors herein by Ruby Ragsdale Graham by deed dated the 18th day of December, 1947 and recorded in the R. M. C. Office for Greenville County in deed volume 333 at page 475.

It is the intention of the grantors herein to convey to the grantee any right, title or interest they may have in the county road.

Grantors assume and agree to pay taxes for the year 1952.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
